# ABOUT THE INSTITUTE



The Philippine Institute for Development Studies (PIDS) was created on September 26, 1977 by virtue of Presidential Decree No. 1201. It was established to respond to the critical and growing need for policy research to aid national development planning and policy formulation. It is organized as a nonstock, nonprofit government corporation.

PIDS research is envisioned primarily to help government planners and policymakers in the executive and legislative branches of government. Its main clientele also consists of the network of agencies that make up the National Economic and Development Authority.

To carry out its mandate, the Institute maintains three basic programs: Research Program; Outreach Program; and Dissemination and Research Utilization Program.

## RESEARCH PROGRAM

The Research Program is concerned with the identification and prioritization of research studies needed in planning and policy formulation; development of research projects and topics; and conduct of research on priority areas/issues for planning and policymaking. Arrangements for research to be subcontracted to research institutions and individuals, in addition to those conducted in-house, are also part of the program.

PIDS research is guided by a research agenda that is examined and updated every five years to reflect new and emerging development issues.

## DISSEMINATION AND RESEARCH UTILIZATION PROGRAM

This program consists of Publications and Circulation, and Public Affairs. The Publications and Circulation subprogram markets PIDS' research outputs to promote their utilization. It fulfills this function through the production of different types of publications that cater to the Institute's varied audiences.

On the other hand, the Public Affairs subprogram organizes and sponsors appropriate fora to provide the proper venue for researchers to present, discuss, and disseminate their research findings to various agencies and institutions, especially to policymakers. The fora delve on issues that may not be part of a completed/ongoing PIDS study but are otherwise critical components of the country's overall development thrust. By focusing on these issues, the Institute is able to immediately respond to the growing demands of the concerned sectors even before it actually undertakes a comprehensive study.

## OUTREACH PROGRAM

PIDS' senior staff provide technical expertise and advice to policymakers and other individuals and organizations to help shed light in the deliberation and discussion of key policy issues and important socioeconomic topics. Whether it is to assist in formulating the country's strategic position on APEC-related issues or in drafting a nationwide tax and tariff reform program or in putting together a set of policy issues on food and agriculture in the Asia-Pacific region, the PIDS senior researchers, in their capacity either as resource persons or as technical advisers, provide the necessary analysis of the outstanding issues.

# RESEARCH AGENDA 2010-2014

Long-term visioning: THE PIDS POLICY RESEARCH AGENDA is anchored on long-term visioning that is deemed more suitable than a medium-term plan. This strategy will help the government address potential issues or problems that may not be urgent now (or maybe so deeply rooted now that they seem virtually insoluble in the short or the medium run) but are likely to be quite important many years or even decades from now, but would take a long time (e.g., longer than the election cycle) and significant resources to be solved by the time the social costs or the foregone benefits from missed opportunities are already quite high.

# PRESIDENT'S MESSAGE



**2**012 was an eventful year for the Philippines. In May, the Senate found Supreme Court Chief Justice Renato C. Corona guilty of some of the charges that led to his impeachment in December 2011. Two major legislative bills were enacted into law: Republic Act No. 10351 or “An Act Restructuring the Excise Tax on Alcohol and Tobacco” and Republic Act No. 10354 or “The Responsible Parenthood and Reproductive Health Act of 2012”. The highlight of 2012 was undeniably the 6.6 percent GDP growth rate that exceeded even the most optimistic forecast.

This year was no less momentous for the Philippine Institute for Development Studies (PIDS). The Institute celebrated its 35th Anniversary and again led the nation in the observance of the 10th Development Policy Research Month (DPRM). A total of 90 institutions actively participated in the staging of various seminars and lectures nationwide for the observance of the DPRM. The theme for 2012 was “Regional Economic Integration and Inclusive Growth: Engaging Nations, Embracing People”. One important reason for the choice of this theme was the approaching establishment of the ASEAN Economic Community (AEC) in 2015. The AEC is expected to boost the formation of a contiguous market and production base among the ASEAN countries that will encourage greater inflows of foreign direct investments into the region. Free flows of capital and goods will expand the opportunities of domestic firms, which will have profound implications on the inclusiveness of economic growth.

As part of its core mandate of conducting policy research, the Institute continued collaborating with other government agencies. In February 2012, PIDS entered into a memorandum of agreement (MOA) with the Commission on Higher Education to support a program on institutional capacity building of leading state universities; one of its components is the **Grants-in-Aid Research for Research Development and Extension**. PIDS prepared a research agenda aimed at improving capacity and performance of state universities and colleges. A major output of this research agenda was a set of recommendations to reform the student financial assistance program.

In November, PIDS entered into a MOA with the Manila Economic and Cultural Office to conduct background studies for determining the feasibility of an **Economic Cooperation Framework Agreement with Chinese Taipei**. PIDS also continued to pursue research activities at the regional level. The Institute completed a mid-term review of the progress of implementation of commitments under the **AEC Blueprint for the Philippines**. As regional coordinator of the East Asian Development Network, it hosted the **EADN Annual Forum** in July.

Several other projects were implemented in partnership with various partners. Among these are: **Health Systems Research Management (HSRM) and Determinants of Non-Communicable Disease Phase II (NCD Phase II)** with the Department of Health, **Zero-Based Budgeting for FY 2013** with the Department of Budget and Management, and **Comprehensive Industry Roadmap** with the Department of Trade and Industry and Board of Investments. In total, the Institute completed 44 studies and was conducting 43 studies by the end of 2012.

On the networking side, the past year was marked by the re-activation of the online database, **Electronic Resource Base for Legislation** or ERBL, which links legislative information with research resources. PIDS redesigned its web facility and updated the site to include major economic bills of the 15th Congress. This was made possible with the assistance of the Congressional Policy and Budget Research Department.

In the area of research dissemination, the Institute continued to organize various fora to gather stakeholders from concerned sectors to discuss critical development issues in the country. A total of 35 events were arranged and sponsored by the Institute, which can be categorized and summarized as follows: 13 Network/Project-related fora; 4 Roundtable Discussions; 2 Press Conferences; 3 PIDS Corner Inaugurations; 3 House of Representatives Forum Series; 5 Pulong Saliksikan Seminars; 3 Regional Consultation Meetings; and 2 Institutional Symposia.

The Institute produced a total of 42 Discussion Papers, 22 *Policy Notes*, and 5 issues of the newsletter, *Development Research News*. A volume each of the *Philippine Journal of Development* and the *Research Paper Series*, and two editions of the *Economic Issue of the Day* were also released. The Institute also published the *2011 Economic Policy Monitor*, the second in this series. It focused on education for development in consonance with the theme of the 2011 DPRM.

Keeping up with the demands of the digital age, the Institute used the social media to update stakeholders of its services and published studies. Its Facebook and Twitter accounts kept journalists abreast with recent developments in the policy research work of the Institute.

The Institute also continued to enhance the **SocioEconomic Research Portal for the Philippines** or SERP-P. A new logo was created and the website was redesigned to facilitate easier navigation for users. A new feature called "Spotlight" was also added in the SERP-P website to highlight current development issues that may be of interest to the public and to disseminate related studies undertaken by SERP-P member-institutions on the selected issue. The Institute also organized a members' meeting in November to re-establish links with the Network members. The meeting's theme, "Moving Policy Research One Step Forward", underscored the goal of optimizing the full potential of the SERP-P as a research network by taking advantage of the strong linkages of the members and utilizing advancements in community technology.

In terms of financial operations, the Institute was successful in sustaining its favorable financial operations. The fourth and final tranche of the implementation of the salary adjustment pursuant to the Senate and House Joint Resolution No. 4 series of 2009 was received in 2012. Salaries of PIDS employees were adjusted accordingly; the adjustment was charged to the Institute's corporate funds. Another achievement of the Institute was passing the Level II accreditation of the Civil Service Commission (CSC) reflecting the Institute's continued compliance with CSC requirements in human resource management.

2012 also marked the beginning of a major transition in the management of PIDS. Jennifer P.T. Liguton, long-time Director of the Research Information Staff, officially retired on July 31. Meanwhile, Mario C. Feranil stepped down as Vice-President on November 30 in preparation for his retirement next year. We take this opportunity to acknowledge the immense contribution of these two pillars to the growth of PIDS.

I would like to express my gratitude and congratulations to the PIDS staff for 35 years of excellent work and service. Your dedication and commitment are the foundation of the Institute's success.

# RESEARCH ACTIVITIES



**O**n its 35th year, the Institute continued to gain momentum in its research work by focusing not just on national policy issues but also on international and regional issues such as the increasing economic integration in the East Asian region. In partnership with several government agencies and international organizations, it advanced its research agenda to issues concerning international collaboration for inclusive growth.

Five major projects were conducted toward this end. Two were executed in cooperation with the Economic Research Institute for ASEAN and East Asia (ERIA) and focused on the role of the ASEAN Economic Community (AEC) in the development of the East Asian Region. These studies were the **ASEAN Economic Community (AEC) Mid-Term Review (MTR) Philippine Country Study** and the **ASEAN Economic Scorecard Phase III—Philippine Country Study**.

The Mid-Term Review provided an assessment on whether the implementation of the AEC Blueprint has contributed or not to economic growth, employment, competitiveness, and social welfare within the ASEAN Community. The Philippines Country Report presented the results of the surveys related to the assessment of the AEC Blueprint on areas including trade liberalization and facilitation, services and investment liberalization, labor mobility, and agriculture. In assessing the progress of implementation of the country's commitments under the AEC, a scorecard mechanism was applied. The report also covered two case studies as well as discussions on the role of the private sector and small and medium enterprises, and concluded with recommendations on how to raise the implementation rate of the AEC measures in the country.

To complement the review, the **ASEAN Economic Scorecard Phase III** was carried out. It was intended to push further the policy and regulatory impetus coming from the drive toward AEC 2015 and beyond. To a large extent, this project was envisioned to continue and deepen the regulatory reform efforts that have been going on in the ASEAN member-states.



The three other projects, **Prospects for a Philippines-European Union (Ph-EU) Free Trade Agreement**, **Philippines-Taiwan (Ph-Taiwan) Economic Cooperation Agreement Feasibility Study**, and **Review and Assessment of Existing Partnerships: Comparative Study on the Different Free Trade Agreements entered into by Japan with Other Asian Countries**, discussed the factors to consider in crafting bilateral agreements and underscored the need to review the country's current trade position with possible trading partners.

Conducted in cooperation with the Department of Trade and Industry, the Ph-EU study provided information, analyses, and insights on having the European Union as a potential trading partner. It specifically provided analyses on the **Implications of the Ph-EU FTA to Philippine Agriculture**, **Implications of the Ph-EU FTA to Philippine Fisheries, Issues and Prospects on the Movement of Natural Persons and Temporary Migration in the Philippines-European Union Partnership**, **Evaluation of European Union's Bilateral FTAs/Learning from Relevant FTAs, An Analysis of Offensive and Defensive Interests in the Manufacturing Sector for the Proposed Philippine-EU FTA (Trade in Goods)**, **Environmental Aspects of a Potential Ph-EU FTA**, **Implications of a Ph-EU FTA to the Philippine Labor Market**, and **Analysis of Specific Legal and Trade-Related Issues in a Possible Ph-EU Economic Partnership: The Philippine Constitution, Competition Policy, Government Procurement, Intellectual Property Rights, Dispute Settlement and Trade Remedies**.

Similarly, the **Philippine-Taiwan study**, which is ongoing as of the reporting period, aims to offer insights on a possible economic partnership between the two countries. Executed with the Manila Economic and Cultural Office for the Philippine Representative in Taiwan, the study also aims to examine the political/diplomatic dimension and viability of a Philippine-Taiwan Economic Cooperation Framework Agreement (ECFA).

Meanwhile, in looking at national issues, the Institute helped draft a bill on the **Student Financial Assistance Program (StuFAP) for Tertiary Education** in partnership with the Commission on Higher Education (CHED). The bill aims to rationalize the allocation of student financial assistance in state universities and colleges. The prominent features in the proposed bill include the creation of the policy coordinating board to solve the fragmentation and lack of coherence of the current StuFAP; the development of an examination-based system for identifying grantees for the different types of financial assistance to ensure that only capable students are given assistance; and regular monitoring and impact evaluation of the StuFAP that will subject the program to rigorous tests for effectiveness and sustainability, among others. The submitted bill was officially adopted as a Committee Report and is now on its second reading. Further studies concerning tertiary education are also being undertaken by the Institute under the PIDS-CHED project **Grants-in-Aid for Research, Development, and Extension of State Universities and Colleges**.

True to its mandate of implementing a comprehensive and integrated research program that will provide the research materials required for the formulation of national development plans and policies, the PIDS, in close coordination with the Board of Investments, is currently facilitating the formulation of a **Comprehensive Industrial Roadmap**. The Roadmap is envisioned to guide the formulation of the Annual Investment Priorities Plan and to aid government positions/strategies in trade and investment negotiations. The project is now at the height of its execution—with PIDS leading in the conduct of consultations with various industries, and is expected to be completed by the third quarter of 2013.

The Institute has also contributed to the assessment of various programs of the Philippine Government. The **Independent Evaluation of School-Based Management (SBM) Grants for FY 2010 and Independent Validation of 2011 Support to Philippine Basic Education Reform (SPHERE) SBM Grants** were implemented under separate MOAs with the Department of Education (DepEd). These studies reviewed the processes undertaken by the different administrative levels of the DepEd in the implementation of the SBM grants from planning to actual utilization and reporting.

Furthermore, in continuance of the PIDS-Department of Budget and Management partnership, seven studies on zero-based budgeting for fiscal year 2013 were being finalized. Under this project, the performance of the following programs was examined against their approved allocations: **Cadastral Survey Program of the Department of Environment and Natural Resources (DENR), Programs Offered by SUCs, Resettlement Program of the National Housing Authority, Reforestation Program of the DENR, Sitio Electrification Program, and Agricultural Production Support Services of the Department of Agriculture**. Findings from these studies served as inputs to the 2012 National Budget.

Using its own research resources, the Institute also completed an independent study on the **Impact Evaluation of the Pantawid Pamilyang Pilipino Program (4Ps) Using APIS 2011**. The study identified the salient features of the 4Ps, discussed the reviews and assessments done so far, and expounded on the issues concerning the targeting scheme and pace of expansion of the program.

PIDS has also been equally active in health policy research. Through its **Health Market Innovation Project** with the Rockefeller Foundation, the Institute has institutionalized the “Galing Likha Kalusugan Award”, which identified and documented 80 innovative health programs in the country. The project culminated with the successful awarding of distinguished health programs.

With funding support from the Department of Health (DOH), the Institute is concurrently implementing the project **Health Systems Research Management (HSRM) in the Department of Health** and the study on **Determinants of Non-Communicable Disease Phase II (NCD Phase II)**.

The HSRM Program is composed of the Health Policy Fellowship Program and the Health Research Program. The Health Policy Fellowship program intends to bridge existing capacity gaps in the health sector and acts as a program to train a new generation of health sector leaders, program managers, policy analysts, and researchers. Under this component, the Institute hired 10 health fellows to be trained in health policy research. Write-shops for the fellows will be organized by the PIDS Health Team.

The Health Research component, on the other hand, seeks to provide evidence-based findings needed to steer the health system, monitor existing health policies and programs, and inform future policies and programs. Under this, different topics on health financing, Health Facility Enhancement Program, and Millennium Development Goals identified by the DOH will be outsourced to PIDS. This component is expected to go full blast by the second quarter of 2013.

In terms of networking, 2012 was marked by the re-activation of the online database **Electronic Resource Base for Legislation** or ERBL, which links legislative information with research resources. PIDS redesigned the web facility and updated the site to include major economic bills of the 15th Congress. This was made possible with the assistance of the Congressional Policy and Budget Research Department. The PIDS had also been active in the preparations for the 5th International Conference of the Latin American Studies Council of Asia and Oceania (CELAO), which was hosted by its long-time partner, the Philippine Academic Consortium for Latin America (PACLAS).

In total, the Institute had 44 completed research studies and 43 ongoing research studies by the end of 2012. Brief descriptions of the completed projects together with a list of ongoing studies are provided in **Annexes D** and **E**, respectively.

# PHILIPPINE APEC STUDY CENTER NETWORK



The Philippine APEC Study Center Network (PASCN) is a regular component project of the PIDS. It was established by virtue of Administrative Order No. 303 issued by President Fidel V. Ramos on 23 November 1996 as the Philippines' response to the APEC Leaders Education Initiative (ALEI). The PASCN's establishment is particularly relevant to one of ALEI's components that calls for the promotion of APEC-related studies and greater exchange of scholars and students among institutions of higher learning in the region.

**R**esearch evidence on its own does not bring about social change; people do. To this end, the Institute continuously promotes its research knowledge to empower policymakers and development planners with evidence-based policy recommendations to inform policymaking and elicit social change.

The Research Information Staff (RIS) is at the forefront in carrying out this mission. The RIS ensures that PIDS researches do not only stay on the shelves but actually reach their intended audiences and users. Various modes of information and education are employed that span from the traditional (publication of books and other printed materials) to modern schemes like the use of social media and networking. Moreover, an integral dissemination strategy of the Institute is its regular engagement with the media that has not only helped promote the Institute's research products to the general public but has also brought the analyses and recommendations of PIDS studies into the popular discourse.

Over the years, the Institute has developed and maintained a great reputation in bringing together diverse voices to discuss critical development issues. Its forums, seminars, and other events have been a meeting place of ideas by experts, practitioners, and learners in the development and public policy fields.

## Publications and Circulation

### Books

In 2012, the Institute produced the second issue of the *Economic Policy Monitor (EPM)*. This issue contained a description of the general macroeconomic conditions and in-depth analyses of timely policy issues. The second issue of the *EPM*, released in May, focused on education. It discussed the sector's achievements, direction, priorities, and critical gaps to help the government and other education stakeholders craft a much-needed education reform agenda.

Meanwhile, four books are in production. The two-volume PASCN book, *Philippines-Japan Economic Partnership Agreement (PJEP): Strengthening the Foundation for Cooperation*, was sent to the press; the first volume will be off the press by the third quarter of 2013. The *Analysis of the President's Budget for 2012* written by Dr. Rosario Manasan is expected to be released by the second quarter of 2013. Layout and design of the book on the results of the 2009 Survey of Innovation Activities, a co-publication with the Department of Science and Technology (DOST), has been completed and forwarded to DOST for printing.

### REGIONAL ECONOMIC INTEGRATION & INCLUSIVE GROWTH

The Institute is actively engaged in advocating the use of research in planning and policymaking in the Philippines. It annually spearheads and organizes the celebration and observance of the Development Policy Research Month (DPRM) every September. Initiated in 2002 through Presidential Proclamation 247, the DPRM aims to increase the public's awareness and appreciation of the importance of policy research in national development planning and policy formulation. The DPRM is envisioned to improve the public's understanding of socioeconomic policy issues and concepts through broad-based discussions and interactions among different stakeholders and sectors.

This year's DPRM was a milestone year with its 10th year anniversary themed "Regional Economic Integration and Inclusive Growth". A total of 90 institutions (**See Annex H-1**) from national government agencies and local government units as well as from the nongovernment, private, and academic sectors supported and participated in the DPRM activities (**See Annex H-2**). The Institute, as in the previous years, was the Chair of the 2012 DPRM Steering Committee, supported by the following member-institutions: Civil Service Commission, Department of Foreign Affairs, Department of Trade and Industry, National Anti-Poverty Commission, National Economic and Development Authority, and the Philippine Information Agency. Among the activities organized were seminars and lectures, roundtable discussions, and media appearances in radio-television talk shows, newspaper and magazine features, and research fair.

## RESEARCH PAPER SERIES

The Research Paper Series contains final research outputs of the research staff and the Institute's various research projects. Titles under this series undergo review by an internal committee and external referees. In 2012, one issue dealing with the richness of rice as a genetic material and resource, as well as the changes it had undergone in the past 100 years in terms of varietal improvement science, was published.

## POLICY NOTES SERIES

The *Policy Notes Series* contains commentary and analyses by PIDS researchers on a wide array of socioeconomic and development topics. Although all PIDS publications are for general circulation, the *Notes* are primarily intended for decisionmakers, in consonance with the Institute's goal of promoting evidence-based policymaking.

The Institute released 22 issues under this series (**See Annex F-3**). They tackled issues on migration, education, agriculture, disaster risk reduction, regional trade, and energy, among others. In line with the celebration of the 10th Development Policy Research Month themed "Regional Economic Integration and Inclusive Growth", most of the policy notes highlighted the importance of regional policy coordination, particularly in the greater Southeast Asian region, in solving the country's development problems.

## DEVELOPMENT RESEARCH NEWS

Five issues of the DRN were released. The January-February issue had PIDS President Dr. Josef Yap's annual review of the Philippine economy of the previous year and his economic forecasts for the current year. This year's review and forecast were co-authored once more by Dr. Yap and Dr. Adoracion Navarro. Yap and Navarro described 2011 as a difficult year for the Philippines, with gross domestic product (GDP) growth registering a dismal 3.7 percent. In their forecast, they looked at potential silver linings and pointed to the stimulus from the government's spending as a factor that could bring about better growth in 2012.

The September-October 2011 issue, meanwhile, focused on the various papers presented at the seminars organized by PIDS to celebrate the DPRM. The lead article was taken from the keynote address delivered by Senator Edgardo Angara during the DOST-PIDS National Forum on Innovation.

The lead feature of the November-December 2011 issue dealt with the importance of local economic enterprises (LEEs) in providing basic goods and services to their constituencies. Improving the performance of LEEs, especially in the aspect of fiscal operations, would thus benefit the people. The issue also featured the "Galing-Likha Kalusugan Award", the first-of-its-kind award-giving body that honors outstanding health system innovation programs in the country.

For the March-April 2012 issue, the lead feature delved on how funds are sourced and used in state universities and colleges (SUCs), and what should be done to improve the efficiency of SUCs' spending to make college education accessible and affordable to students. Another story in this issue tackled the environmental costs brought about by the over-extraction and degradation of the environment and natural resources.

The main feature of the May-June 2012 issue explained why the official poverty line underwent revisions. Another story delved on the increasing incidence of climate-related natural disasters in Asia-Pacific and highlighted the need for political leaders and economic managers to recognize the critical link between climate change response and economic success, and why investing in adaptation and mitigation actions is critical.

Meanwhile, the main feature of the July-August 2012 issue discussed late school entry and the demand-side barriers to primary schooling. The second article discussed the importance of expanding development to the local levels to spur economic growth. The third article underscored the importance of knowledge sharing, particularly among academics, researchers, and policymakers, to effectively implement development policies and programs.

## PHILIPPINE JOURNAL OF DEVELOPMENT

The *Philippine Journal of Development* (PJD) is a professional and academic journal that underscores various aspects of Philippine development particularly the economy, business, politics, governance, international relations, and other development-related fields of study. The 2010 first semester issue went off the press in July. Production work on the 2010 second semester issue started in the fourth quarter of 2012, while articles for the 2011 first semester issue are being prepared for copyediting.

Topics of the 2010 first semester issue included social capital, rice trade policy reforms, land degradation, population growth and economic development, and regional patterns of manufacturing industries in Indonesia. The article on social capital emphasized the need to examine the characteristics of farmer networks within the framework of optimizing the risk-adjusted return from new technology. Another article analyzed the effects of rice trade policy reforms on household welfare, as indicated by changes in consumer and producer prices, using nonparametric regression and density estimation. The review on land degradation compiled and evaluated estimates of the costs of land degradation; analyzed the costs, benefits, and equity implications of priority measures to protect soil resources; and drew implications for policy. The issue also tackled the ongoing debate on the impact of population growth on economic development, with the Philippines as a case study. The last paper discussed Indonesia's manufacturing industry, exploring whether regional specialization and industrial concentration patterns changed during the 1998-2007 period.

## ECONOMIC ISSUE OF THE DAY

To better educate the public on the concepts behind certain economic and development issues, the Institute publishes the *Economic Issue of the Day* (EID) series that defines and explains basic economic concepts as they relate to current and everyday matters. For this year, two issues of the EID were released. The first issue dealt with the public-private partnership (PPP) concept, its characteristics and types, as well as possible limitations. The second issue explained the K to 12 Basic Education Program and its opportunities and challenges.

## DISCUSSION PAPER SERIES

The Institute released 42 titles (**See Annex F-5**) under this series. Discussion Papers are preliminary results of researches conducted by the Institute's research staff and collaborators, circulated to elicit comments and suggestions that could further refine and improve these studies, especially in relation to methodological and technical matters.

## OTHERS

Aside from its regular publications, the Institute also produced a Souvenir Program for the 35th founding anniversary of PIDS and the 10th Development Policy Research Month. An updated PIDS brochure was also printed.

## DISTRIBUTION, PROMOTION, AND CIRCULATION

To ensure that research outputs reach their intended publics, the Institute maintained its distribution and circulation activities by sending publications to its regular recipients and subscribers, and attending to walk-in customers. It regularly posted digital copies of its studies and publications on its website to provide clients immediate and convenient access, and to reach a broader readership. The Institute also regularly updated its website and issued email alerts on new publication releases as part of its promotional efforts.

The Institute further strengthened its partnerships and linkages with local and international institutions through its PIDS Corners (see separate section for details) and Library Development Program. To broaden research promotion, the Institute likewise maintained licensing agreements with various information dissemination entities.

## SocioEconomic Research Portal for the Philippines (SERP-P)



Following the successful members' meeting on November 20, the SocioEconomic Research Portal for the Philippines (SERP-P) Network has grown into 50 member-institutions, with over 5,000 studies available in the SERP-P website by the end of 2012.

The members' meeting was attended by 80 participants representing 33 research and academic institutions. It was organized to reestablish links with the member-institutions as well as to gather inputs and suggestions on how to optimize the full potential of SERP-P. As part of the preparation for the members' meeting, a memorandum of agreement (MOA) between the PIDS and each member-institution was also prepared. The aim is to formalize the partnership and to ensure the commitment of the members to the network. By the end of 2012, 12 member-institutions have already signed and submitted the finalized MOAs.

Furthermore, the SERP-P website was enhanced to facilitate easier navigation for users. It was given a new theme and a new logo to attract more members and users. A new feature called "SocioEconomic Issue on Spotlight" was also added in the SERP-P website. This feature highlights critical issues that may be of interest to the public and related studies conducted within the last five years found in the SERP-P about the selected issue. In addition, a Social Sciences Experts Directory will be added to the website as proposed by the PIDS Management. The SERP-P team is gathering the list of experts from all network members which will serve as the preliminary content of the directory.

## Public Affairs

### EVENTS MANAGEMENT

Over the years, the Institute has organized numerous events that have brought diverse voices together from a range of sectors to discuss critical development issues in the country. A total of 35 events were arranged and sponsored by the Institute in 2012.

The Institute's various fora have played an important part in bringing its expertise and research outputs to the public front and, more importantly, in bridging research, policy, and practice. For instance, the Institute's partnership with the House of Representatives and the Senate have helped in influencing national policies and programs on health, education, finance, trade, and poverty alleviation, among others. International and regional conferences and seminars, on the other hand, have been instrumental in keeping policymakers abreast with international developments and have been valuable venues for knowledge-sharing and best-practice learning. The Institute has likewise increased its provincial dissemination activities to help in keeping local audiences informed on key policy and development issues.

Keeping up with the digital age, the Institute capitalized on its Facebook and Twitter pages, providing regular updates of its research products and dissemination activities.

## MEDIA EXPOSURE MONITOR

Integral to the Institute's dissemination strategy is its regular media engagement. This strategy has not only helped in promoting the Institute's research products and results, but has also contributed in providing analyses and insights to public discourses, and policy deliberations. In 2012, with improved media monitoring, the Institute listed a record-high of 321 media exposures. As in the previous years, the print media, notably national dailies such as the *Business World*, *Business Mirror*, *Philippine Daily Inquirer*, and *Philippine Star*, remain as the Institute's most vigorous partners in research dissemination. Major broadcast stations, both TV and radio, likewise carried news and feature stories on the Institute's activities and research outputs.

## Library Development Program

The PIDS Library continued supporting the Institute's various activities and serving the needs of both in-house and outside researchers. A total of 135 new books and 113 new journal articles were added to its collection in 2012. It has also maintained its usual exchange of publications with both local and foreign institutions as well as its subscription to major newspapers and magazines.

Three new PIDS Corners were established and inaugurated in 2012 in the following locations: House of Representatives Library in Quezon City; Mariano Marcos State University Library in Batac, Ilocos Norte; and Central Luzon State University Library in the Science City of Muñoz, Nueva Ecija. Launched in 2006, the PIDS Corner is a dissemination and outreach strategy that aims to bring the Institute's research outputs to researchers and policymakers in localities and communities outside of Metro Manila. There are now 21 PIDS Corners located across the country. Apart from making various development and policy-oriented materials more accessible in the provinces, the Corners also serve as a means to help in furthering the economic education of constituencies in various localities.

# PIDS hosts 5<sup>th</sup> Research Fair

A highlight of the 10<sup>th</sup> Development Policy Research Month (DPRM) was the holding of a Research Fair.

Research Fair 2012 showcased an abundance of research materials relevant to policymaking from 19 exhibitors that consisted of government agencies and academic and research institutions. Aside from promoting evidence-based policymaking, the Fair was intended to encourage knowledge sharing and dissemination among various stakeholders and to serve as a supplement to the seminar series on regional economic integration and inclusive growth which was the theme of the 10<sup>th</sup> DPRM.

The Fair was open for public viewing from September 24 to 26 at the Salas Hall, NEDA sa Makati Bldg., 106 Amorsolo Street, Legaspi Village, Makati City.

Students (mainly from Metro Manila), educators, government officials, and business people visited the Fair. Complimentary copies and for-sale brochures, books, and other information materials about ongoing and completed studies were made available by the exhibitors for their guests. They all came ready not only with printed materials but also with the latest multimedia equipment to promote their studies.


A friendly competition among the exhibitors is held every Research Fair to recognize the institution with the most attractive and creatively designed booth. For this Fair, the Bangko Sentral ng Pilipinas (BSP) booth was unanimously chosen by the exhibitors, the viewing public, and selected PIDS staff over its closest rivals, the UP Center for Integrative Studies (2007 Best Booth awardee) and the Institute for Labor Studies. The criteria for the best booth gave importance to informative/educational content, the physical arrangement of the booth, the evaluation of visitors and Fair exhibitors, and the quality of customer service demonstrated by the exhibitors.

Research Fair 2012 was the fifth of its kind organized by the Institute. The first Research Fair was held in 1999. It was revived in 2002 during the Institute's 25<sup>th</sup> founding anniversary. Since then, it has been a regular activity in every milestone year of PIDS in celebration of its founding anniversary and in support of the DPRM.

The PIDS Provident Fund was established on April 29, 1999. It was registered with the Securities and Exchange Commission (SEC) on January 25, 2000. It was organized to establish and maintain a fund from the contributions of members and counterpart contributions of PIDS. All earnings from its investment operations are distributed to the members as benefits. The PIDS provided P2 million seed money to the Fund as authorized by the PIDS Board Resolution No. 97-05, s. 1997 dated July 24, 1997. The PIDS Provident Fund, Inc. was conceived to complement the GSIS and Pag-Ibig Fund benefits of PIDS employees. Its primary objective is to provide additional benefits to retired/resigned/separated PIDS employees.

As of December 31, 2012, the Fund has a total membership of 78 permanent PIDS member-employees and three co-terminous PASCN employees.

The 12th Annual Members' Meeting of the PIDS Provident Fund held on April 16, 2012 at the Romulo Hall of the NEDA sa Makati Building was highlighted by the following activities: (1) presentation of the annual report and audited financial statements by the Fund President; (2) proposed declaration of dividends; and (3) election of level representatives to the Board of Trustees.

The PIDS Provident Fund maintains an intranet website and online information system that allows each member to check on real time the accumulated balance of their contributions to the Fund including its earnings.

For CY 2012, the Fund paid provident fund benefits in the total amount of P2.501 million to seven employees who resigned/retired from PIDS.

The Fund also distributed dividends that totalled P0.076 million to qualified members of the Fund pursuant to Section 7, Amendment No. 4 of the By-Laws of the Fund.

In terms of financial performance, the Fund's assets increased by 9.4 percent from P30.248 million in 2011 to P33.088 million in 2012. These assets were distributed among cash and cash equivalent, accrued interest receivables, short-term investments, and long-term investments.

As to the members' equity account, the members' equity increased in 2012 by 9.8 percent, from P27.645 million in 2011 to P30.362 million in 2012. The members' equity consists of members' contributions, PIDS contributions, and dividends.

In terms of revenue generation for CY 2012, the Fund earned revenues of P1.686 million and spent P0.210 million in operating expenses, resulting in a net income of P1.476 million in 2012 that is 1.2 percent lower than the P1.495 million earnings in 2011. The decrease in net income during the year can be attributed to the higher share in net income of resigned/retired members that was deducted from the net income. Figure 1 above shows the trend in the net earnings of the Fund during the last 10 years (2003-2012).

# PIDS EMPLOYEES ASSOCIATION



Just like any employees organization, the PIDS Employees Association (PIDSEA) is an organization where members bond together for a common objective and purpose. The Civil Service Commission (CSC), as prime advocate of public employee empowerment, assists both the management and the employees organization in establishing a working environment that promotes harmonious relations, enhances employees' welfare and productivity, and contributes to the attainment of a responsible public service.

The year 2012 was a very busy and fruitful year for PIDSEA. This has been achieved because of the full cooperation of all the members with the support of PIDS Management. The following activities of the Association in 2012 prove this:

PIDSEA organized a Christmas Party for the children of its members. Even the young nieces and nephews of employees were also invited to join in the fun. Employees, PIDS Management, and Senior Fellows mingled with the young ones who came in dressed as cartoon characters and superheroes in line with the theme of the party. This was also the first time that food booths serving hotdogs and tacos and an ice cream cart were made available, courtesy of PIDS president, Dr. Josef T. Yap.

The PIDSEA will be celebrating its 12th anniversary in July 2013. Hoping for more fruitful years for our employees association!

### **1. GENERAL INFORMATION**

The Philippine Institute for Development Studies (PIDS) is a nonstock, nonprofit government research institution created under PD 1201 in September 1977. The Institute's nature of operation/principal program/activities include, among others, the following:

- 1.1 Provide analyses of socioeconomic problems and issues to support the formulation of plans and policies for sustained social and economic development in the Philippines;
- 1.2 Establish a continuing channel of communication between policymakers and planners, on one hand, and researchers, on the other;
- 1.3 Establish a repository for economic research information and other related activities.

The Institute's principal place of business is at NEDA sa Makati Building, 106 Amorsolo Street, Legaspi Village, Makati City.

### **2. SIGNIFICANT ACCOUNTING POLICIES**

The Institute's financial statements have been prepared in accordance with the State's accounting principles.

- 2.1 Errors of prior periods that are material in amount were corrected in accordance with paragraphs 41-50 of Philippine Accounting Standard (PAS) No. 8, Accounting Policies, Changes in Accounting Estimates and Errors.
- 2.2 Inventories were valued at cost using moving average method. These included costs of unused supplies and materials, books, journals and working papers for various research projects for sale.
- 2.3 Investments in bonds were amortized at cost using the straight-line method. Interest income pertaining thereto and that of the investments in treasury bills were recognized on accrual basis.
- 2.4 Property, plant and equipment (PPE) were recorded at cost less accumulated depreciation. The straight - line method of depreciation was used based on the estimated useful life ranging from five to 10 years. A residual value computed at 10 percent (10%) of the cost of the asset was set and depreciation started on the second month after purchase. Property, plant and equipment (PPE) acquired by externally-funded projects were recorded as Held-in-trust. PPE that were not used in operations were reclassified to other assets.
- 2.5 Liabilities were recognized at the time these were incurred.
- 2.6 Income and expenses were recorded using the accrual method of accounting.
- 2.7 Transactions in foreign currencies were recorded in Philippine Peso based on the BSP rate of exchange at the date of transactions. At the end of the year, these were revalued using the rate of exchange at balance sheet date.

### **3. CASH AND CASH EQUIVALENTS**

Cash and cash equivalents comprise cash in bank and demand deposits, together with other short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

The Endowment Fund which was established under the same law that created the agency was purposely meant for investment, the earnings of which shall be used in the operational requirements of the Institute.

The Investment capital-held in trust represents the total cost of fixed assets purchased and used in the implementation of externally-funded projects (Note 8).
