



# ABOUT THE PHILIPPINE INSTITUTE FOR DEVELOPMENT STUDIES

The Philippine Institute for Development Studies (PIDS) was established on 26 September 1977 to respond to the country's critical and growing need for research for planning and policy formulation. PIDS was established by virtue of Presidential Decree No. 1201. PIDS is organized as a nonstock, nonprofit government corporation.

In general, PIDS research is envisioned to help government planners and policy-makers in the executive and legislative branches of government. Its primary clientele consists of the network of agencies which make up the National Economic and Development Authority.

Broadly stated, the goals of PIDS are:

- To develop and implement a comprehensive and integrated research program that will provide the research materials and studies required for the formulation of national development plans and policies;

# **PROFILE OF SPEAKERS**



### Delia Albert Board Member, Asian Institute of Management; Former Secretary of Foreign Affairs, Government of the Philippines

Ambassador Delia Domingo Albert is the first woman career diplomat to become Secretary (Minister) of Foreign Affairs in Asia. She represented the Philippines in Switzerland, Romania, Hungary, the Federal Republic of Germany and the Commonwealth of Australia.

As Chair of the United Nations Security Council in 2004 she introduced the agenda "The Role of Civil Society in Post-Conflict Peacebuilding".

She attended the University of the Philippines, the Institute of International Studies in Geneva, the Diplomatic Institute in Salzburg, Boston University Overseas in Bonn, the J.F. Kennedy School of Government at Harvard University, among others.

The Philippine Women's University conferred on her Doctor of Humanities, honoris causa for building a gender-fair society and was awarded "Most Distinguished Alumna of the University of the Philippines in 2012.

For her meritorious and exceptional service to the country she was conferred the Order of Sikatuna rank of Datu and was given the title of "Bai-A-Rawatun sa Pilimpinas" for assisting Muslim women in their search for peace and development. She received the Knight's Commander's Cross of the Order of Merit with Star (BundesVerdienstKreuz) from the Federal Republic of Germany and the single award to celebrate 70 years of Philippine-Australia relations in 2016 from the Australian government.

Ambassador Albert is a member of the advisory board of the Institute for Cultural Diplomacy in Berlin; the Asian Institute of Management; and the Global Summit of Women. She is the founding chair of Business and Professional Women Philippines (Makati Chapter) Diwata: Women in Resource Development and adviser to the Filipina CEOs Circle.









### Satinder Bindra Principal Director, Department of External Relations Asian Development Bank

Satinder Bindra is the Principal Director, Department of External Relations (DER) at the Asian Development Bank (ADB). He assumed office in August 2013.

Prior to joining ADB, Mr. Bindra was the Spokesperson and Director of Communications at the United Nations Development Programme in New York, USA. From 2008 to 2011, he was a member of the senior management team and Director of Communications at the United Nations Environment Programme in Nairobi, Kenya.

Earlier in his career, from 1987-2007, Mr. Bindra worked for CBS News, CNN, the Canadian Broadcasting Corporation, The Canadian Press and India Abroad News Service in a variety of roles such as senior international correspondent, South Asia bureau chief, producer and reporter.

Mr. Bindra, a Canadian national, holds a Master's degree in International Relations from Oxford University; and Master's and Bachelor's degrees in the Economic History of China/Japan and Indian and European History respectively, both from St. Stephen's College, Delhi University.



## Jikyeong Kang President, Dean, and MVP Chair in Marketing Asian Institute of Management

Jikyeong Kang became the tenth and first female President CEO of the Asian Institute of Management (AIM) on 6 October 2015, only nine months after joining AIM as Dean, Senior Vice President of Marketing, and MVP Professor of Marketing. She continues to hold the position of Dean at the Institute.

Since joining AIM, she has intensified faculty engagement based on shared aspirations and a sharpened focus on thought leadership in key subject areas of management. Working with the faculty and external stakeholders, she has spearheaded a strategic review of AIM as well as a redesign and alignment of its portfolio of offerings beginning with the flagship MBA program.







Prior to assuming her post at AIM, Jikyeong was the Director of the DBA Programme at Manchester Business School (MBS) from 2010 to 2014. In the Financial Times rankings, MBS achieved the number one spot for Doctoral Programs from 2011 to 2013.

She also served as Director of the Postgraduate Centre in charge of MBS' MBA Programmes from 2001 to 2007, where she was instrumental in propelling the full-time MBA Programme's Financial Times ranking from 47th in the world in 2002 to 22nd in 2007, the highest ranking that the Programme has ever achieved. Whilst she was in charge of the MBA Programmes, MBS became one of the first schools in the world to earn triple accreditation (AACSB, EQUIS, and AMBA).

Jikyeong has been the recipient of various research grants and has delivered consultancy work for many global organizations. She has also won several national and international awards for her research and actively publishes her work in various academic research journals. In 2005 Jikyeong was highly commended in the Public Sector for Asian Women of Achievement Award in the U.K.

Jikyeong has also taught around the world as a Visiting Professor, including IE in Spain; RSM in the Netherlands; CEIBS in China; and Sogang Graduate School of Business in Korea.



## Peter McCawley Author, Banking on the Future of Asia and the Pacific: 50 Years of the Asian Development Bank

Peter McCawley is an economist from the Arndt-Corden Department of Economics at the Australian National University (ANU) in Canberra, who has worked on development issues in Asia and the Pacific for many years.

He has a PhD in economics (1972) from the ANU. He later taught at Gadjah Mada University in Yogyakarta in the early 1970s before becoming head, Indonesia Project, at the ANU. In 1986, he joined Australian Aid as a Deputy Director General.

Much of his work in Asia has been with the Asian Development Bank (ADB). Between 1992 and 1996, he was a member of the ADB Board of Directors. Later, in 2003–2007, he became Dean of the ADB Institute in Tokyo.

He was also Co-chair and Chair of Asian Development Fund







negotiations between 1999 and 2008.

He has numerous publications about development issues in Asia and the Pacific.

## Takehiko Nakao President, Asian Development Bank

Takehiko Nakao is the President of the Asian Development Bank (ADB) and the Chairperson of ADB's Board of Directors. He was elected President by ADB's Board of Governors and assumed office in April 2013.

Before joining ADB, Mr. Nakao was the Vice Minister of Finance for International Affairs at the Ministry of Finance of Japan.

In a career spanning more than three decades, Mr. Nakao has gained extensive experience in international finance and development. He has held senior positions in the Ministry of Finance in Japan, which he joined in 1978, including Director-General of the International Bureau, where he fostered close ties with leading figures in the Asia-Pacific region, and G20 nations.

He was assigned as Minister at the Embassy of Japan in Washington D.C., between 2005 and 2007, and from 1994 to 1997 served as economist and advisor at the International Monetary Fund.

He has published books and numerous papers on financial and economic issues, and in 2010 and 2011 was a Visiting Professor at the University of Tokyo.

Born in 1956, Mr. Nakao holds a bachelor's degree in Economics from the University of Tokyo and a Master of Business Administration from the University of California, Berkeley.



### Alfredo Pascual Trustee, Philippine Institute of Development Studies; Former President, University of the Philippines

Alfredo E. Pascual, former president of the University of the Philippines, joined the Philippine Institute for Development Studies (PIDS) as a member of its Board of Trustees in March 2016.

As UP President from 2011 to February 2017, Mr. Pascual implemented bold reforms and programs to achieve academic excellence and operational excellence, transform UP into a research-intensive









university, raise its international profile as a global university, and strengthen it as a public service university, pursuant to a strategic plan. He raised substantial resources from government, donations, and revenue-generating projects. Billions of pesos were earmarked for modernizing the physical and cyber infrastructure of the campuses and the hospital equipment of it 1,500-bed hospital. To further extend the reach of UP, he established new specialized campuses through government funding and donor support. He rolled out eUP, an integrated information system designed to achieve administrative efficiency; instituted the Green UP program to make the campuses environment friendly and sustainable; and initiated quality management certification.

Prior to UP, Mr. Pascual worked at Asian Development Bank (ADB) for 19 years in such positions as Director for Private Sector Operations, Director for Infrastructure Finance, and Advisor for Public-Private Partnership. He undertook pioneering projects and institution-building initiatives for the region and in several countries. He spent years of posting in India and Indonesia. He represented ADB on the corporate board of over a dozen ADB investees (e.g., banks, funds, financial institutions, and manufacturing companies) in such countries as the People's Republic of China, India, and the Philippines.



### Ernesto M. Pernia Secretary of Socioeconomic Planning National Economic and Development Authority Government of the Philippines

Dr. Pernia has close to 18 years of experience at the Asian Development Bank (ADB), starting as Economist, rising to Senior Economist, Principal Economist, and then Lead Economist. He developed and directed projects in various Asian countries on investment climate and productivity, economic growth and poverty reduction, education and health, human resource development, and regional economic cooperation. He led staff and a dozen consultants that produced the seven-volume study on the "East ASEAN Growth Area: Brunei Darussalam, Indonesia, Malaysia. Philippines" (1996) – which provided the roadmap for the implementation of the landmark regional cooperation undertaking. He also represented ADB at various international development conferences in North and Latin America, Europe and Africa, besides Asia.

He has chaired the board of trustees of the University of San Carlos (2011-2014), having been a trustee since 2005; and was a director on the board of the Philippine-American Academy of Science and Engineering (2008-2013). Currently, he is on the board of Holy Name University (Tagbilaran). He also sits on the board of the Philippine-Russian Business Assembly, and previously on the board of the First







Philec Solar Corporation. Further, he serves on the board of several NGOs, including the Philippine Center for Population and Development, Forum for Family Planning and Development, Friendly Care Foundation, and Bahay Tuluyan -- with the organizations variously involved in promoting quality education and health, science and technology, poverty reduction, improved governance, and population and development.

Dr. Pernia had been Professor of Economics and Chairman, Department of Economics at the UP School of Economics, and previously Director for Research. He was a Visiting Research Fellow at the East-West Center Resource Systems Institute in Honolulu, and was Regional Adviser on population and employment policy for Asia and the Pacific with the International Labour Organization. He has served as a consultant to various international organizations, including the World Bank and UN agencies.

He obtained his PhD degree from the University of California Berkeley on a Ford Foundation scholarship and a Smithsonian Institution dissertation grant. He was granted the Balik Scientist award by the Department of Science and Technology (DOST). He received the first award as Outstanding Young Scientist (economics and social sciences) from the National Academy of Science and Technology. He is a former President of the Philippine Economic Society and Co-Chair of the Federation of ASEAN Economic Associations (1988).

He has written and contributed to several books, and wrote numerous articles in international professional journals. Dr. Pernia was chosen in February 2015 by the Philippine-American Academy of Science and Engineering (PAASE) for the Science Award. In March 2011, he received the Achievement Award for social sciences from the National Research Council of the Philippines, DOST. In 2009, he was accorded the Outstanding Boholano Around the World award (economics). He is ranked 7th among 250 scientists in the Philippines, according to Google Scholar Citations public profiles.

He was an occasional contributor to the Philippine Daily Inquirer Op-Ed section, the BusinessWorld, and The Philippine Star's Science section.
