Adoption of the Philippine Health Information Exchange (PHIE) Lite

I. RATIONALE

The Department of Health (DOH) and the Philippine Health Insurance Corporation (PhilHealth) have used information and communication technologies (ICTs) to enhance the efficiency and productivity of their works and service delivery capabilities. Applications and information systems have been built to solve agency specific objectives and/or problems; however, these systems were not designed to communicate with each other and data collection is not harmonized. At present, health facilities are using two (2) systems which use differing technology platforms, solutions, and standards to satisfy the requirements of both agencies. At times, this poses a dilemma, especially when similar information and/or reports are needed to be submitted to both agencies, resulting to redundant and duplicate submission of the same sets of information. As such, the health sector, through the leadership of the DOH, recognized the need to harmonize both agencies' common business processes and employ an internormability structure for their technical

Research Highlights from the Philippines Study

AMR

- 77% of the patients buy antibiotics in quantities less than 14
- 50% of the patients buy antibiotics in quantities ranging from 1-6, this is less than half of the standard prescribed dosing for antibiotics

TB

- 52% of the time, patients buy individual medicines (monotherapies) for TB instead of standard of care (combination therapies)
- 1 in every 2 patients buys less than 10 pills, 1 in every 3 patients only buys 1 pill per transaction which is highly sub therapeutic
