Sector Expert/Consultant for Teacher Development

<u>Research for Second Congressional Commission on Education - Study on Teacher's Specialization and Subject-Taught Mismatch</u>

1. Background and Rationale

The Philippine Institute for Development Studies (PIDS) will conduct research needed by the Second Congressional Commission on Education (EDCOM 2).

Section 3 of Republic Act No. 11899 states that the objective of creating EDCOM 2 is "to undertake a comprehensive national assessment and evaluation of the performance of the Philippine education sector for the purpose of recommending transformative, concrete and targeted reforms in the sector." In addition, the bill states that national assessment and evaluation will include the following:

- 1. review of the observance of the mandates of the laws that created the three education subsectors, namely the DepEd, the CHED and the TESDA;
- 2. determination of factors that have contributed to the continuing failure in learner performance on identified subject areas to meet the desired international and local standards;
- 3. recommendations comprising of specific, targeted and time-bound solutions to enable the education sub-sectors to improve performance vis-à-vis measurable indicators and deliver accessible, inclusive and quality education that is at par with world standards;
- 4. identification of best practices of various national and international educational institutions that can be adopted across the entire education system;
- 5. proposal for a monitoring and evaluation plan to ensure the timely achievement of set targets;
- 6. determination of the role of local government units in the delivery of basic education services; and
- 7. additional legislation to further the objectives of this Act.

The conduct of the abovementioned studies is in relation to the role of the PIDS in EDCOM 2. As stated in the EDCOM 2 Act:

"The Philippine Institute for Development Studies (PIDS) shall serve as the research arm of the Commission. During the course of the Commission's existence, it shall produce data-based research and provide analysis to contribute to the formulation of education policy recommendations."

2. Objectives of the Study

In an attempt to resolve the learning crisis reflected by the international assessments and as aggravated by external factors such as the COVID-19 pandemic, the PIDS studies for EDCOM2 will be conducted to gather literature and data from which a strengthened policy can be drawn to address the identified learning gaps and losses, and to achieve the objectives set by the commission.

The study will be guided by the following research questions and objectives:

- 1. What is the extent of teacher's specialization and subject-taught mismatch?
- 2. How important is it as a factor in student outcomes?

General

Understand the extent and importance of teacher specialization and subject taught mismatch in student outcomes.

Specific

- 1. Measure the extent of teacher specialization and subject-taught mismatch in elementary and secondary schools.
- 2. Identify the reasons for the mismatch.
- 3. Estimate the relationship between teacher specialization and subject-taught mismatch and student test scores.
- 4. Provide policy recommendations

3. Objectives of the Consultancy

- To assist the Project Director/Principal investigator in the conduct of the study from inception to presentation to stakeholders in various fora
- To provide expert-level inputs for the duration of the study
- To ensure achievement of study's goals and objectives

4. Scope of Work, Deliverables, and Schedule of Payment Releases

Under the oversight and with management/administrative support of a PIDS Research Fellow who serves as Project Director/Principal Investigator, the Consultant¹ will be assigned **as Co-Principal Investigator / Sector Expert** for the project, Research for the Second Congressional

Commission on Education (EDCOM 2). He/ She is expected to work with the Project Team and provide technical assistance in the conduct of the following tasks²:

- 1. Co-write with the Project Director/Principal Investigator, and other members of the study team the required reports and participate in the conduct of project activities such as:
- a. Research Study Inception Report
- b. Desk review of relevant literature
- c. Data analysis and presentation
- d. Draft Discussion Paper
- e. Policy Notes
- f. Research workshop presentation
- g. Final research report/Discussion Paper
- h. Presentation of findings to the Second Congressional Commission on Education
- i. Other documents as required of the Project
- 2. Liaise with the Project Director/Principal Investigator for their inputs in the reports; consolidate, review and integrate their submitted outputs, and ensure timely submission of deliverables
- 3. Provide inputs to a data management and quality control plan which will be used for data collection.
- 4. Assist in supervising and performing data collection, processing, and analysis; lead the implementation of the research design.
- 5. Moderate Key Informant Interviews (KIIs) and Focus Group Discussions (FGDs) sessions, and attend consultation meetings as needed by the team. Prepare/submit the transcript of KIIs and FGDs³.
- 6. Present the findings of the study in an internal research workshop and before the Second Congressional Commission on Education together with the Project Director/Principal Investigator and other consultants.
- 7. Sign a Non-Disclosure Undertaking with PIDS. Any information gathered and generated in the implementation of the project shall be processed subject to the applicable

The specific research approach will be fully discussed in the inception phase and once the consultants are onboard.

6. Project Duration

The engagement will commence from signing of contract until December 2024. The Consultant's work must be completed within this period, and no man days will be chargeable after this date.

7. Approved Budget for the Contract

The approved budget for this consulting service is up toPhp 548,100.00. The final contract price will depend on the consultant's qualifications. This amount covers the professional fees of the Consultant. It does not include the costs of data collection (such as FGDs, KIIs and surveys and logistical costs), which will be defrayed by PIDS. The Consultant's work must be completed by December 2024 at the latest, and no man days will be chargeable after this date. Moreover, PIDS shall not cover hospitalization and other COVID-related health expenses of the consultant as no employer-employee relationship exists between the PIDS and the Consultant.
