TERMS OF REFERENCE

Healthcare Facility Quality-of-Care Consultant

Implementation of Select CY 2023 Research Priorities of the Department of Health (DOH) through the Philippine Institute for Development Studies under the AHEAD-HPSR Program: Health Facilities and Enhancement Program (HFEP)

1. Background and Rationale

The Department of Health (DOH) has provided a research grant to the Philippine Institute for Development Studies (PIDS) to conduct studies under the two essential pillars of the health sector: (1) human resources for health (HRH) and (2) capital health investments. The former, which comprises multiple objectives, examines the current state of benefit schemes for healthcare workers in the Philippines and evaluates the potential impact of HRH policy reforms (e.g., salary standardization and full implementation of the Magna Carta), while the latter examines the Health Facilities Enhancement Program or HFEP, one of the Department's most extensive programs, accounting for about 11% of its budget (Department of Budget and Management 2023). Both of these studies are of critical importance.

Component 2: Health Facilities Enhancement Program (HFEP)

The pandemic has exposed perennial challenges in the health sector, particularly the limited supply of health facilities and healthcare workers. According to the 2020-2040 Philippine Health Facility Development Plan (PHFDP), the Philippines has the lowest bed-to-population ratio (1.2 per 1,000) in the ASEAN region. Maldistribution is a challenge (Department of Health 2020b). Most health facilities are concentrated in poor areas in the country. The government has instituted reforms to address these challenges in the past ten years. The HFEP was first implemented in 2010 to augment capital investments in the country by providing grants to local governments for building/refurbishing health facilities and purchasing equipment. This study evaluates the HFEP, a capital investment grant to local governments in terms of equity and efficiency.

2. Objectives of the Study

The general objective of the study is to evaluate the Health Facility Enhancement Program (HFEP) of the Department of Health (DOH) using an equity and efficiency lens. It will also examine the fidelity in implementing the program and identify key challenges, particularly in resource allocation, monitoring, and disbursement. Specifically, it aims to:

i. Conduct descriptive analyses of the HFEP disbursement data to determine whether the program is equitably and efficiently allocated.

ii. Conduct a process evaluation of the program to determine issues and challenges, particularly in the following key areas: resource allocation, planning and monitoring, and disbursement.

3. Objectives of the Consultancy

The general objective of this consultancy is to engage a consultant to support the analysis of quality-of-care data collected through clinical vignettes administered to healthcare providers in selected facilities across the Philippines as part of the HFEP study. Specifically, the consultancy aims to:

- Analyze clinical vignette data to assess the quality of care delivered by healthcare providers.
- Provide insights and recommendations based on the analysis of quality-of-care, focusing on equity, efficiency, and areas for improvement.
- Offer technical support in interpreting the vignette results and identifying potential policy interventions to improve the quality of care in healthcare facilities.

4. Scope of Work, Deliverables, and Schedule of Payment Releases

Under the guidance and technical oversight of a PIDS Research Fellow, who serves as the Project Director, the **Consultant**¹ is expected to work with the Project Team and undertake the following tasks/activities²:

- 1. Analyze clinical vignettes on quality of care administered to healthcare providers across selected facilities in the Philippines.
- 2. Provide technical inputs to ensure accurate interpretation of the vignette data, focusing on quality-of-care measures, patient safety, and outcomes.
- 3. Write a technical report summarizing the findings of the vignette analysis, including recommendations for policy and operational improvements based on the identified gaps.
- 4. Attend internal workshops/meetings and present findings and insights to relevant stakeholders (e.g., DOH, PhilHealth, PIDS).
- 5. Prepare a final report incorporating feedback from data validation workshop and ensure proper turnover of data and materials.
- 6. Prepare for, attend, and present at internal workshops/meetings or client meetings with PhilHealth, DOH, and other stakeholders, as necessary.
- 7. Sign a Non-Disclosure Undertaking with PIDS. Any information gathered and generated in the implementation of the project shall be processed subject to the applicable provisions of the Republic Act No. 10173, known as the "Data Privacy Act of 2012" and its Implementing Rules and Regulations and relevant issuances of the National Privacy Commission (NPC).

5. Qualifications of the Consultant

The Consultant should have the following qualifications:

- a. Post-graduate degree in Medicine, Public Health, Health Policy, or related fields.
- b. At least 5 years of professional experience in quality of care, patient safety, and quality improvement.
- c. At least 5 years of professional experience in the development and use of clinical vignettes.
- d. Experience working in health systems research or health policy is preferred.

6. Project Duration

The engagement will commence upon the signing of the Contract until December 30, 2024, on a parttime basis. The Consultant's work must be completed within this period, and no man days will be chargeable after this date.

Guidelines for Authorship in PIDS Research Projects shall apply.

7. Approved Budget for the Contract

The approved budget for this consulting service is up to PHP 115,680.00, depending on the qualifications. This amount does not include travel and accommodation during fieldwork. PIDS will shoulder the cost of fieldwork. PIDS shall not cover hospitalization and other COVID-related health expenses of the consultant as no employer-employee relationship shall exist between the PIDS and the Consultant.
