#### TERMS OF REFERENCE

## Catering Services for the Araw ng Parangal at Pasasalamat

## I. Objective

The Philippine Institute for Development Studies shall hold **Araw ng Parangal at Pasasalamat** for the retiring employee, Dr. Aniceto C. Orbeta Jr. on **June 23, 2025**. The activity aims to conduct ceremony for the appreciation and granting of Service Award to retiring employees in accordance with Article IV, Sec. 12, PIDSEA Collective Negotiation Agreement.

#### II. Participants

At least One hundred twenty (120) PIDS officials and employees are the expected participants of the activity. The caterer must be ready for a buffer just in case there will be increase in number.

### III. Requirements

### A. Menu (minimum requirement)

- · Buffet Lunch:
- ✓ at least with 4 viands (Fish, Chicken, Pork/Beef, Vegetables)
- ✓ steamed rice
- ✓ at least 1 dessert (salad / fresh fruits / pastries)
- ✓ Soun
- ✓ Bottomless Iced Tea/Juice
- Other:
  - ✓ Free-flowing coffee and/or tea and drinking water during activity.
- B. Serving Schedule (1 day June 23, 2025)
- Buffet Lunch 12:00PM

### C. Scope of Services

 Ingress one day before the event or the setup should be finished before 10:00AM;

- Ensure quality of food and drinks prior to actual serving and cleanliness of dinnerware and utensils to be used;
- Set-up at least one (1) managed buffet station, well-arranged and covered by red and white linen;
- Must have at least two (2) staff/servers for the assistance in distribution of food and drinks and one (1) coordinator;
- Egress immediately after the program (3:00PM).
- Round table set-up with covered chairs based on motif.
- Preferably include event decorations based on the motif or theme.

# IV. Approved Budget for the Contract

The Approved Budget for the Contract is **Ninety Thousand Pesos** (PhP90,000.00), inclusive of all applicable government taxes and service charges.

#### V. Mode of Procurement

The mode of procurement shall be Small Value Procurement which covers provision of food/catering services under the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 12009.

### VI. Payment Scheme

Full payment of the contract shall be paid within fifteen days (15) days after the issuance of the following:

- a. Billing statement by the Service Provider; and
- b. Certificate of Satisfactory Service issued by PIDS

### VII. Liquidated Damages

Failure to comply with the Terms and Conditions of the contract will result in the payment of corresponding penalties/liquidated damages in the amount equal to one-tenth of one percent (1%) of the cost of unperformed portion for every day of delay. If the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of contract. The PIDS reserves the right to rescind the contract, without prejudice to other courses of action and remedies open to it.

## VIII. Dispute Agreement/Resolution:

A. Should there be any dispute related to the Contract and/or rights of the parties arise, the same shall be submitted to mutual consultation, mediation, and

arbitration, in the order of application. The venue of the proceedings shall be in Quezon City.

B. Any amendment or additional terms and conditions to the Contract must be in writing, signed and acknowledged by the Parties.
