RESOLUTION NO.

A RESOLUTION APPROVING THE DEVOLUTION TRANSITION PLAN (DTP) OF THE BARANGAY PROVIDING THE BARANGAY GOVERNMENT WITH A ROADMAP TO ENSURE STRATEGIC, SYSTEMATIC AND COHERENT ACTIONS TOWARDS THE FULL IMPLEMENTATION OF FUNCTIONS, SERVICES AND FACILITIES TO BE FULLY DEVOLVED BY NATIONAL GOVERNMENT AGENCIES (NGAs) CONCERNED STARTING IN FY 2022

WHEREAS, Section 25, Article II of the Constitution provides that the State shall ensure the autonomy of local governments;

WHEREAS, Section 6, Article X of the Constitution provides that local government units (LGUs) shall have a just share, as determined by law, in the national taxes which shall be automatically released to them;

WHEREAS, Section 2 of the Local Government Code (LGC) of 1991 (RA 7160) provides that the

The clarity and conciseness of the Devolution Transition Plan forms cannot exceed the knowledge and capacity of LGU employees and officials tasked to fill out the said forms.

It is indeed significant to collect a comprehensive list of baseline indicators, especially at LGU level, to facilitate a proper monitoring and evaluation of the devolution agenda in the country.

Information is power and we have to maximize the opportunities to collect them.

ANO ANG TRANSITION TO FULL DEVOLUTION?

Ang transition to full devolution ay nag-ugat sa petisyon nina Batangas Governor Hermilando Mandanas at dating Bataan Governor Enrique Garcia, Jr. na naglalayong isama ang lahat ng koleksiyon at tax mula sa mga iba't-ibang ahensya ng pamahalaan sa pagkalkula ng National Tax Allotment (NTA) ng mga lokal na pamahalaan.

Dahil sa nasabing petisyon na sinang-ayunan ng Korte Suprema, magkakaroon ng karagdagang pondo ang mga lokal na pamahalaan upang magamit sa pagpapatupad ng mga programa at tungkulin na itinakda ng Local Government Code of 1991 at iba pang mahahalagang batas.

Kaakibat ng nasabing pagtaas ng pondo ng mga lokal na pamahalaan ay ang pagbaba ng pondo ng mga ahensya ng pamahalaan. Dahil dito, nilagdaan ang Executive Order No. 138 noong Hunyo 1, 2021 kung saan nakasaad ang mga tungkulin at responsibilidad ng mga lokal na pamahalaan at ng mga iba't-ibang ahensya.

ANO ANG MAGIGING SUPORTA NG NASYONAL NA PAMAHALAAN SA Mga pamahalaang lokal?

Ang nasyonal na pamahalaan, sa pamamagitan ng DILG-Local Government Academy at ng iba pang mga ahensya ng gobyerno ay mangunguna sa pagbibigay ng technical assistance at mga capability development interventions katulad ng mga pagsasanay upang lalong maging epektibo ang kanilang pagpapatupad ng mga devolved functions.

Para sa mga LGUs na hindi sapat ang pondo, magkakaroon din ng Growth Equity Fund (GEF) upang punan ang mga kakulangan sa pagpapatupad ng mga devolved functions. ANGAT LOKAL

TRANSITION TO FULL DEVOLUTION

There is a need to revisit the devolution transition period.

The study revealed that none of the provincial, city, and municipal LGUs reported meeting the 100% full devolution target by the end of 2024.

Extend the devolution transition period and continue to capacitate LGUs to appropriately implement the devolved functions.


